# **Ongoing Business:**

#### 1. DELAC

The Berryessa School District was chosen for the Federal Program Monitoring (**FPM**) process. In general school districts that receive funding for the EL programs may be chosen for a review by the state. The purpose of the review is to ensure that they are spending the funding as required by law. At the end of each review, the state will complete a report that details any findings of non-compliance and informs the school district how to correct the findings.

### 2. School Reopening Plan

Due to the current surging of numbers of COVID patients, also the Governor's school opening plan is very restrictive, the school district is inclined pushing the school opening to the next school year Fall. Still in the negotiation process. Also vaccination distribution to the educators (Tier 1-b) will delay. There is the County's COVID vaccine website to check the vaccine's availability. Each teacher will register and take vaccines individually. There is no state mandated regulation that teachers must take the vaccine before they return to the classroom.
